WORLD: POLICE BRUTALITY (USA)

Human rights are certain rights which we are entitled to. They play a crucial role in any society by protecting us from arbitrary and unjust discrimination.

Police brutality is the use of excessive or unnecessary force by law enforcement officers when dealing with suspects and civilians. From the beginning, those who engaged in police brutality have acted with the implicit approval of the local legal system, such as during the Civil Rights Movement

era. In countries with high rates of killings by police, there is often a combination of factors including inadequate laws, racial or other forms of discrimination, insecurity or conflict and favouritism. Racism along with police brutality is deadly, as it colours a law enforcer's opinion about a suspect. Police officers are more likely to stop African- Americans without a criminal record than Caucasian or Asians with criminal records. This depicts a disturbing trend.

On March 13, Louisville police officers knocked down the apartment door of 26-year-old African American Breonna Taylor, serving a no-knock search warrant for drug suspicions. Police fired several shots during the encounter which led to her death. For weeks after Taylor's death, her family, members of the community, and protesters around the world requested that officers involved be fired and criminally charged.

Police brutality is a dangerous situation, as it is an abuse of power by those who are meant to protect us. It violates the right to be free from discrimination, the right to liberty and security, and the right to equal protection under the law.

#### WORLD: ROHINGYA GENOCIDE (MYANMAR)

To Whom It May Concern

Human rights are basic rights that belong to all of us. They are key values in our society such as fairness, dignity, equality and respect. They are an important means of protection for us all, especially those who may face abuse, neglect and isolation.

A key violation of these human rights is the violence against Rohingya Muslims. The Rohingya genocide is a series of ongoing persecutions and torture by the Myanmar government of the Rohingya people, a minority ethnic Muslim community. The crisis forced over a million Rohingyas to leave behind their homes and lives to flee to other countries. These Rohingya Muslims have gone through targeted killings, gang tapes, torture, and acts so heinous that they are considered genocide. Thousands of Rohingya women have been raped, sexually assaulted, or abused in some way or the other.

In August 2018, the office of the United Nations High Commissioner for Human Rights declared that Burmese military generals should be tried for genocide

when they reported their findings of the investigation into the August–September 2017 events. On 23 January 2020, the International Court of Justice ordered Myanmar to prevent genocidal violence against its Rohingya minority and to preserve evidence of past attacks.

The international attention and condemnation this issue has received pales compared to the atrocity of acts committed against the Rohingyas. They need to be helped, and Myanmar must ensure that its minority populations are safe.

To Whom It May Concern



**WORLD: MINORITY LANGUAGE BAN (SLOVAKIA)**

Human rights reflect the minimum standards necessary for people to live with dignity. Human rights give people the freedom to choose how they live, how they express themselves, and what kind of government they want to support, among many other things. Human rights also guarantee people the means necessary to satisfy their basic needs, such as food, housing, and education. This is why human rights are important for every citizen living in the world.

One of the cases where international human rights are violated is forbidding the use of indigenous languages (the right to participate in cultural life). The Slovak parliament made it largely illegal for its citizens to use any language other than Slovak. The use of minority languages in "official" situations is now punishable by fines of up to €5,000. The 2009 amendment has been severely criticized by Hungarians in Slovakia, as well as the government, civil organizations and general public of neighbouring Hungary, for being discriminatory toward Hungarians and their rights to use their Hungarian language.

It is necessary for people living in Slovakia to have the right to speak whatever language they want. It is their space, their area and therefore they should be comfortable living in it. It will not be possible until they can communicate freely in their regional/known language.

Khaled Drareni, an Algerian journalist, was arrested on the 7th March 2019 while covering a protest. He was released later but was arrested again on the 27 March 2019 and has been locked up ever since. His arrest and imprisonment signal an escalation in the crackdown on freedoms in Algeria and are a major blow to Algerians' hopes for reform. On 15th September Khaled was sentenced, on appeal, to two years in prison for "incitement to unarmed gathering" and "harming the integrity of national territory". It is crucial for the future of human rights in Algeria that he is set free. His voice was an important one and no democracy can survive by silencing voices, rather than creating dialogue.

INDIA: CURTAILING THE RIGHT TO DISSENT

Human rights are a set of principles that apply to all individuals- regardless of their race, ethnicity, sex, age, religion, caste or socioeconomic status. These rights guarantee freedom, equality, security and well-being. No individual or government should be allowed to violate these rights.

In September, the Government of India passed three farm bills and received fierce backlash from the farmers in Punjab and Haryana. They travelled to Delhi in peaceful protest. When they were not granted their desirable spot for protest, they took to the streets. The police threw tear gas and water

It is our duty to simply allow them the right to protest peacefully.

This is a complete violation of one of our most fundamental human rightsthe right to dissent.

#### INDIA: CENSORSING THE FREEDOM OF SPEECH AND EXPRESSION

The right to freedom of expression is an essential part of any democracy and a vital part of our constitution. This right includes freedom to hold opinions and to receive and impart information and ideas without interference by public authority and regardless of frontiers. The ability to express our opinion and speak freely is essential to bring about change in society. Putting limits on freedom of speech only creates a slippery slope where more and more beliefs and stances become censored, edited, or never heard.

In May 2012, police in Tamil Nadu filed sedition complaints against thousands of people who had peacefully protested the construction of a nuclear power plant in Kudankulam. Despite a ruling by the Indian Supreme Court that freedom of expression cannot be suppressed on account of threats of violence, the police routinely arrest individuals based on the reactions to their speech.

Stand-up comedian Kunal Kamra faced contempt charges over a series of tweets criticising the Supreme Court for granting TV anchor Arnab Goswami interim bail on Wednesday. This was a controversial judgement, and his right to comment on it was encroached upon.

We must protest against the constant political censorship, as we fight to hold on to our shared values as a nation, and fight for democracy.

This was an atrocious attempt to curb the freedom of expression and limit the powers of the press. This was a horrible human rights violation which needs to be addressed. INDIA: INTERNET SHUTDOWN IN KASHMIR

This was an affront of the right to free speech, and we must work towards making sure this right is not violated.
